FIRST AID

NOT FOR AGRICULTURAL USE

SUPER STRENGTH BLUE DYE WSB is an indicator dye that is mixed into spray tanks in order to color areas that have been sprayed, thereby increasing precision when applying tank mixes. The colorant dissolves in water and does not permanently mark or stain most surfaces. The color fades naturally over time. **SUPER STRENGTH BLUE DYE WSB** does not react with or affect other tank mix ingredients.

SUPER STRENGTH BLUE DYE WSB is packaged in convenient 4 ounce water-soluble packages for easy handling. Simply add packages to a backpack sprayer or spray tank and allow them to dissolve. The blue dye will disperse evenly throughout the tank.

DIRECTIONS FOR USE

Add **SUPER STRENGTH BLUE DYE WSB** to the tank last. **SUPER STRENGTH BLUE DYE WSB** dye is totally water soluble and dissolves rapidly, especially when agitation is applied.

The dye in **SUPER STRENGTH BLUE DYE WSB** will temporarily stain porous surfaces such as concrete, wood, etc. and will take longer to fade than surrounding areas. The product must be used with caution around these materials.

USE RATES

Amount of **SUPER STRENGTH BLUE DYE WSB** Amount of solution
1 - 2 packets 50 gallons

Start at the lowest rate and test an area. If the indicator is not dark enough, add more until desired result is achieved. Shorter and/or lighter areas will require less colorant. Denser or darker foliage or shaded areas will need more colorant.

STORAGE, HANDLING AND DISPOSAL

DO NOT FREEZE

STORAGE: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F. Store in a cool, dry place away from fire, flame or other sources of ignition. Protect product packets from exposure to moisture or high humidity. Do not handle with wet hands. Always reseal outer packaging immediately after the packets are removed. **SUPER STRENGTH BLUE DYE WSB** may appear to be slightly reddish in color, when in packet. The colorant is blue when added to water.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
